We see the inequity of the impacts of Covid-19 on the communities that have been hit hardest by this health and economic crisis. It is also the same as the impacts of climate change.

in hindsight cost fractions compared to the widespread devastation to our food and water sources, habitable locations, and human lives. Although our air is cleaner and we have emitted less GHG's during this stay-at-home order, it is not sustainable and we need to plan and better execute our climate goals even during our current recovery process. Upon ramping back up, Milan, Italy is looking at implementing dramatic new transportation policies after their shutdown has drastically increased their air quality and reduced their GHG production (see April 23rd Forbes.com article). As a society, we will survive this pandemic but that cannot be said for a future where the planet may not be able to sustain human life as we know it. At PCL, planning and executing better climate policies is our number one priority.

Although it is hard to imagine things being completely back to normal anytime soon, the PCL staff have continued to work hard to keep our environmental planning and enforcement priorities front and center during these remote working times. We are still engaging stakeholders and officials on critical issues and continue working on projects that advance our climate goals such as VMT and equitable infill (see PCL.org/Infill), disaster recovery, and GHG mitigation. We also have heightened alertness on protecting California from the federal administration's roll-back on environmental protections and water, fossil-fuel, and air quality standards. This is currently happening during this global crisis despite demands to suspend any dismantling of environmental requirements. An example would be our current engagement in several legal water cases against federal and state agencies on contract agreements. We don't need to sacrifice our environmental health and natural resources for a short-term economic benefit.

We need your help during these challenging times to keep our important work moving forward. This is an opportunity to focus on climate change and other environmental priorities during the recovery process, and if we are going to invest in infrastructure and jobs in the state and across the country, let's focus on projects for the 21st century such as renewable energies, public transportation, water conservation and recycling, and climate adaptation and mitigation programs. Now is the time to invest in the infrastructure of tomorrow and help create jobs and opportunities for the future. Your contribution during this time is even more critical than usual. Because many of you are financially strained as jobs disappear and financial reserves shrink, contributions to PCL are down.
