### PCL Symposium a Resounding Success

More than 200 participants packed into King Hall at the UC Davis School of Law this past Saturday to discuss the past, present and future of the California Environmental Quality Act at the [Planning and Conservation League/PCL Foundation's annual legislative symposium](#). This year's event, entitled **CEQA, Yesterday, Today, Tomorrow?**, started with a thought-provoking plenary panel headlined by State **Senators Michael Rubio and Noreen Evans** as well as speakers from the infill and environmental justice community. The day-long event included 10 [additional sessions](#) focused on exploring where the California Environmental Quality Act is helping to ensure sustainable land-use, transportation, water and energy planning, while exploring where the law may be improved. **Senate President pro Tem Darrell Steinberg** gave the luncheon keynote address, discussing his perspective on the future of CEQA, while Senator Evans and the Center on Race, Poverty and the Environment received awards for their work to defend and enforce CEQA.

PCL will now take the information gathered at the symposium to help develop and promote a positive CEQA reform agenda that will strengthen the law's ability to promote strong environmental outcomes while continuing to empower communities to have a meaningful say in the decisions that impact them. ## **Advocates Reason for Optimism**

With the beginning of the 2013 legislative session, the watch is on for which legislators get appointed to which committees, as those decisions have major bearing on how environmental legislation will take shape over the year. Both Senate President pro Tempore [Darrell Steinberg](#) and Speaker of the Assembly [John Perez](#) have filled key environmental committees with a slate of solid green appointments, for which PCL is very thankful.

The [Senate Environmental Quality Committee](#), Chaired by Senator Rubio, received a number of great appointments, which will hopefully ensure it continues to be a leading voice on environmental protection in the Legislature. Not to be outdone, Speaker Pérez has filled the Committee on Natural Resources, Chaired by Assemblymember Chesbro, with a majority of green voices and votes as well. These are, of course, not the only committees that touch on environmental protection...a number of committees, ranging from toxics and water to parks, energy and transportation, will all play a direct role in environmental bills, while committees that deal with budget, the judiciary and economic development will likewise have a major – albeit sometimes less direct - influence on environmental legislation.
